- 1. Thunes Clote, Marie Day and Graeme Davies from QLDC attended the meeting and spoke on progress and proposed timeline for the camping ground to be vacated of permanent structures and be redeveloped as a campground. The RFP process for a new commercial lease had opened on 19th July. The existing O'Rourke lease would end on 31 January 2020. All permanent structures should be removed between 1 February 2020 and 30 April 2020. The new commercial lease would commence on 1 May 2020.
