Matters arising

1. Ella attended the Martin Jenkins workshop On 18 February which is part of the consultation project and was commissioned by QLDC on QAC's air noise boundary expansion. The selected community groups got invited to 6x different workshops, the list of involved groups is attached. She feels community groups are well represented along with business community and key stakeholders. FCA were only given a few days' notice prior to the date of workshop. There were 6x community representatives at our workshop: Frankton, Kelvin Heights, Arrowtown, Lake Hayes & Shotover country, Glenorchy and Jacks point. Martin Jenkins's two senior consultants led the meeting. We are to be provided with the PPT of Martin Jenkins presentation at this workshop which she requested. It was evident that there was a very strong and united voice from different community groups to oppose the airport expansion. This was

noted by the consultants. We had a group activity to give our opinions on the positive and negative impacts of the potential airport expansion. She believes all participants at the workshop understand the economic benefits but are deeply concerned about the negative impact of airport expansion. The top two negative impacts were unanimously agreed as the noise and pressure on current infrastructure. We were also given four different scenarios of Airport expansion to rate based on economic, social and environmental impacts as well as the overall impact on our community. We were given a sheet with some key data and the proposed four scenarios. These four scenarios were proposed by QLDC and QAC. We were also given the opportunity to propose the 5th scenario if none of the four given scenarios meets our expectation. The given four scenarios were strongly criticised by majority of community representatives and also led to the discussion on credibility of Martin Jenkin's involvement as well as the perception of this consultation project. Martin Jenkins will present the findings after 6x workshop to QLDC by March, and QLDC will make the ultimate decision on the future of QAC expansion. Due to limited number of attendees invited to these workshops, there is an online survey available from 20 Feb to 11 March to public to share thoughts on QLDC's website. Here is the link.
