Frankton Master Plan

Glyn and Kirsty gave feedback on the last workshop where the draft plan was presented.

A few points to note:

1. BP Roundabout to Glenda drive to become an urban highway with mixed use and commercial buildings lower levels with high density residential above up to 4 storeys. Buildings to front the street at the road boundary.
2. Margaret Place change of zoning from Industrial to High density residential
3. Proposing a constant Orbital Bus system linking the separate parts of Frankton.
4. A couple of road overpasses at both SH6 entrances to Frankton
5. Golf course to be moved, to make way for a proposed emergency center hub and bus hub.

ORC Water Taxi Business case

Final workshop was critiquing the draft report. At this stage the water service will be limited to an enhanced service within the Frankton Arm, and if Market forces by way of Tender show that an extension to Remarkables Park (Kawarau River) is viable then it will be added to the proposal.

Lakes Housing Trust

Glyn made comment regarding the Housing Trusts presentation at our recent AGM, regarding inclusionary zoning. Glyn requested that the FCA should consider supporting the Housing trust by way of submission to the third stage of the proposed district plan that inclusionary zoning should be included.

Frankton Beach Upgrade

Erin present on the progress of the Frankton Beach Upgrade. The plan has been updated to include the 150 year flood line, resulting in discussion on how to protect the earth mounds from lake flooding. Further discussion was had with respect to the original plan blocked the bike trail, which has resulted in the path being made wider to accommodate cyclists.

ACTION: Erin to finalise design with QLDC and Baxter's with n aim to present final version to QLDC Community and Services Committee.

McBride Street Parking

General discussion on how the Frankton Parking business case was progressing and how the McBride Street concept of splitting the street in two to stop through traffic.

Peter expressed his concern that the 2 hour parking restrictions were not being policed and would like to see them extended further into old Frankton.
